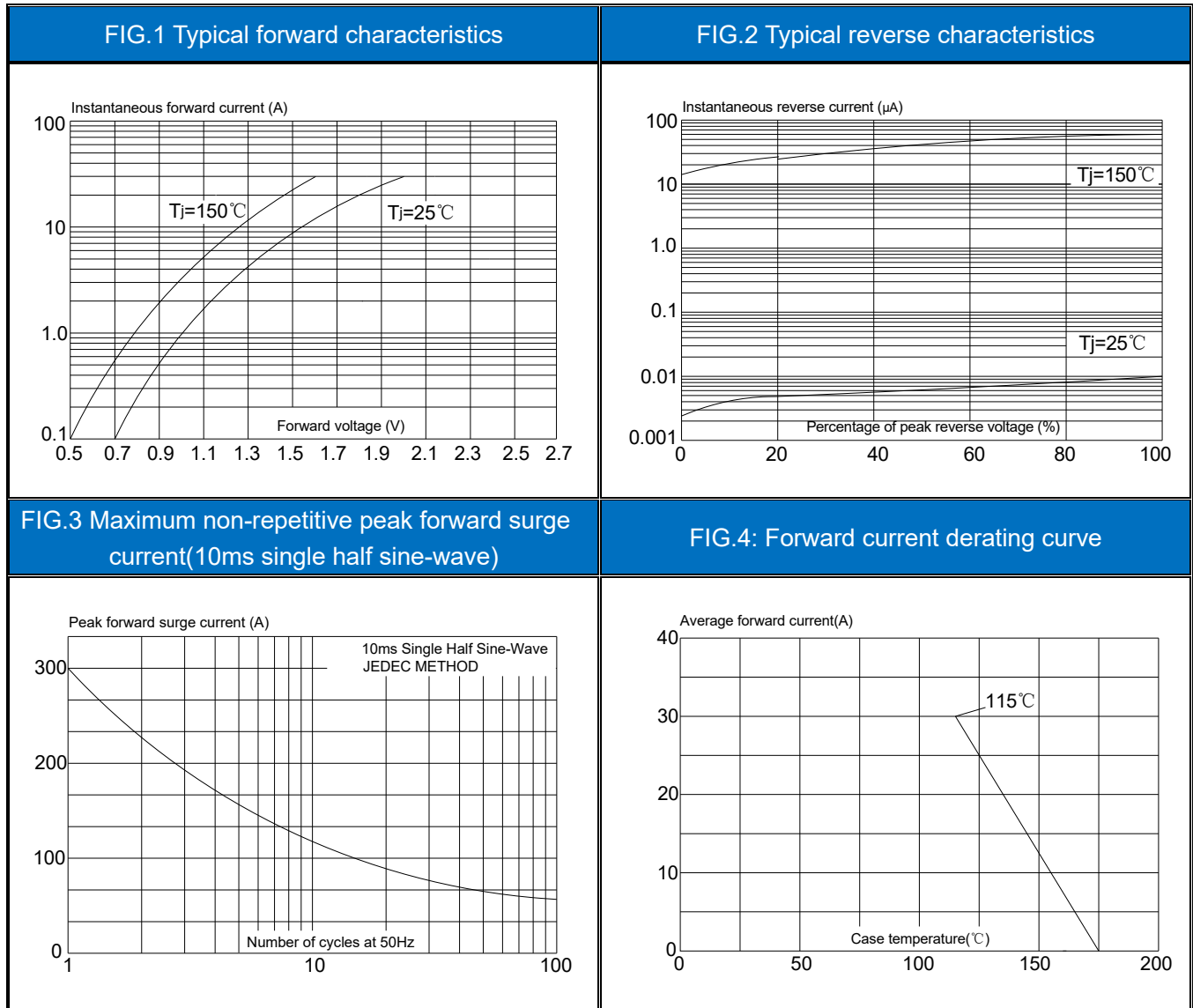
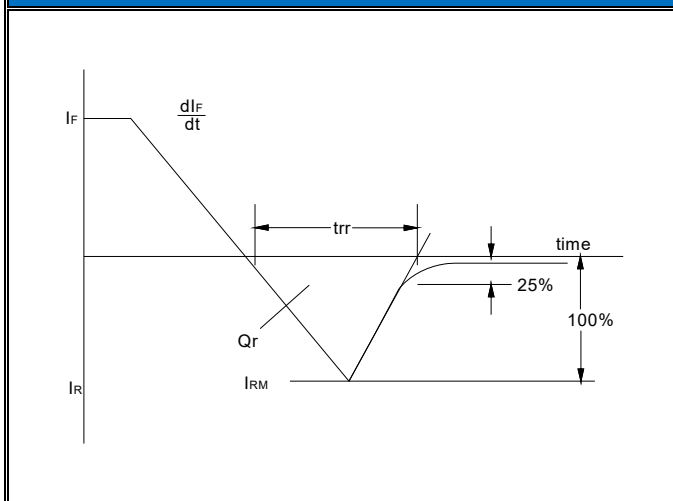


FIG.5: Reverse recovery definitions
