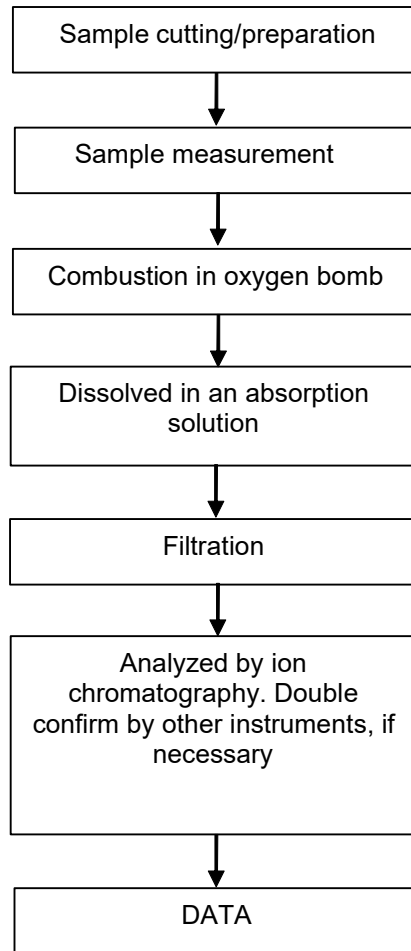

Halogen Testing Flow Chart

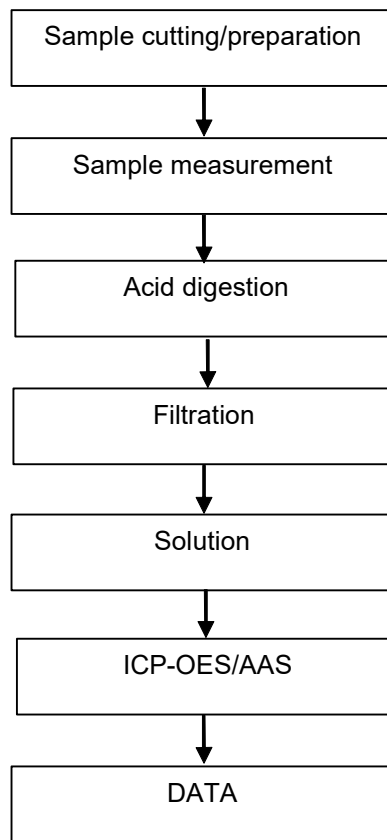

Elementary Testing Flow Chart

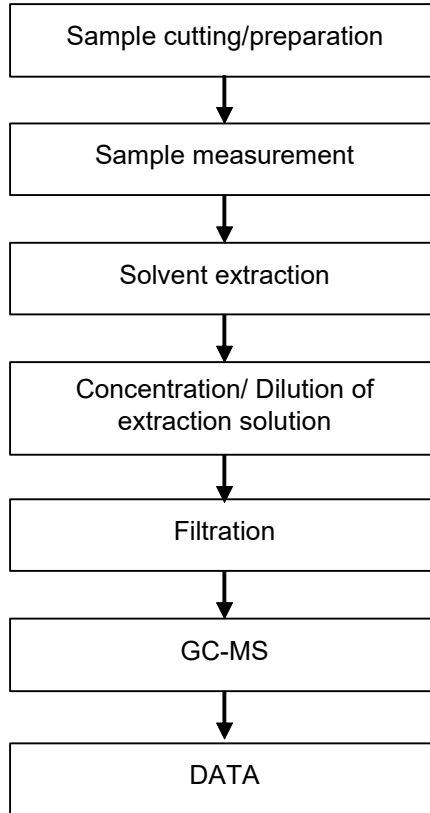

PBBs/PBDEs Testing Flow Chart

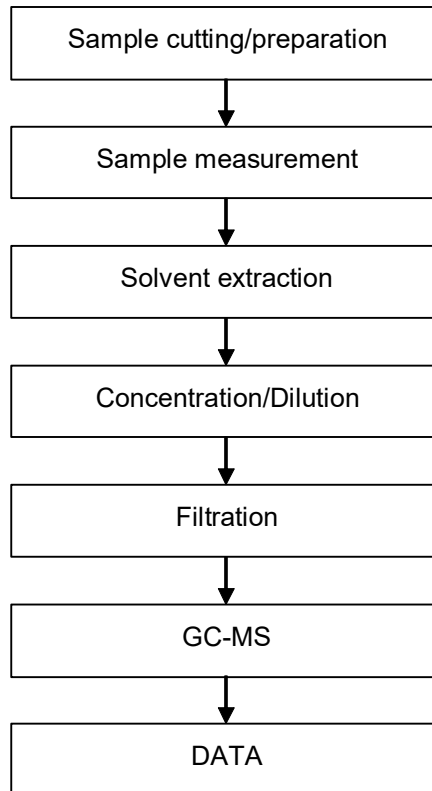

Phthalates Testing Flow Chart

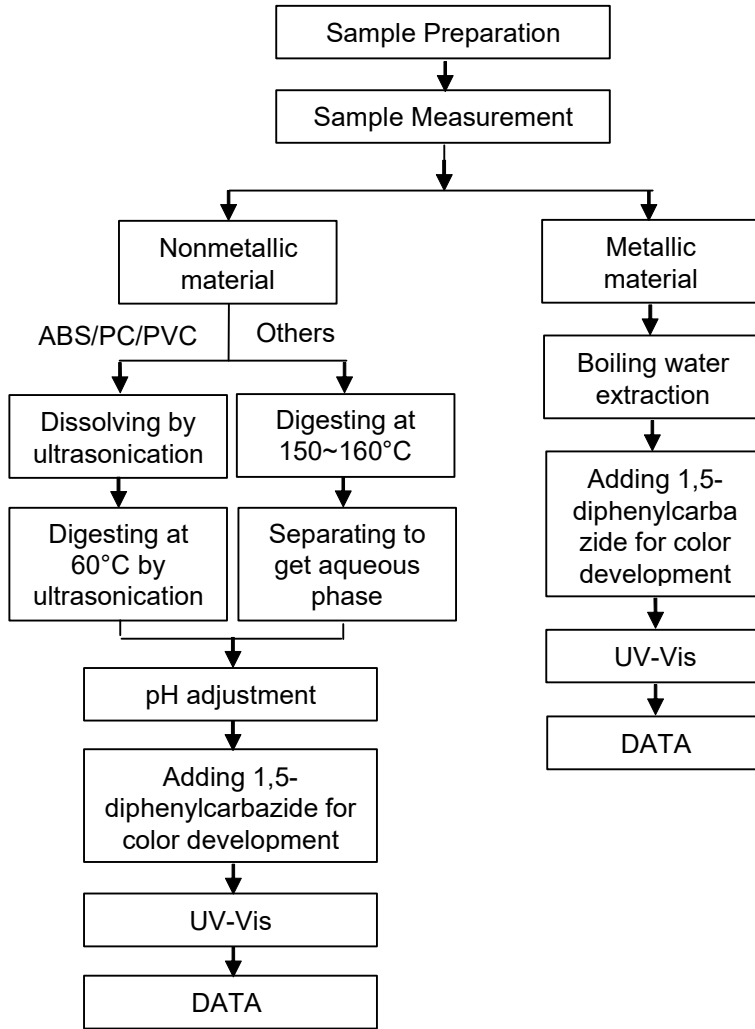

Hexavalent Chromium (Cr(VI)) Testing Flow Chart



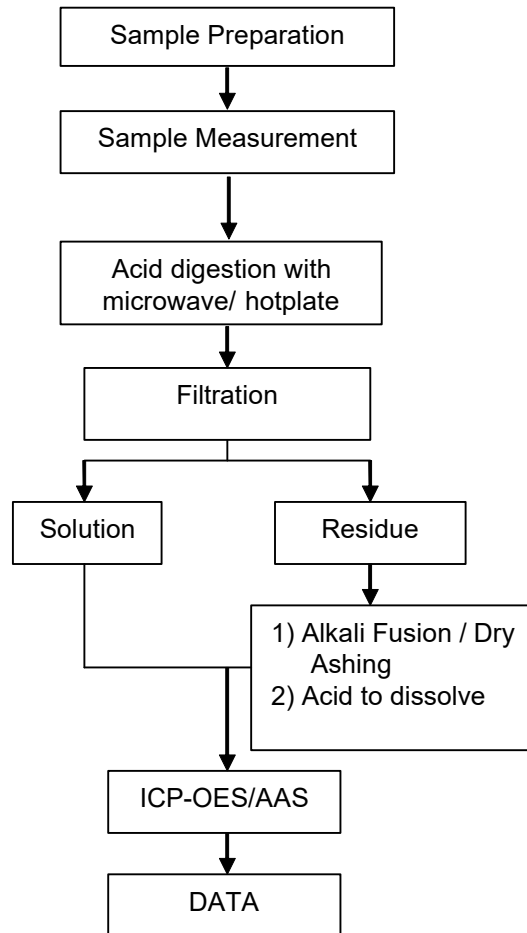

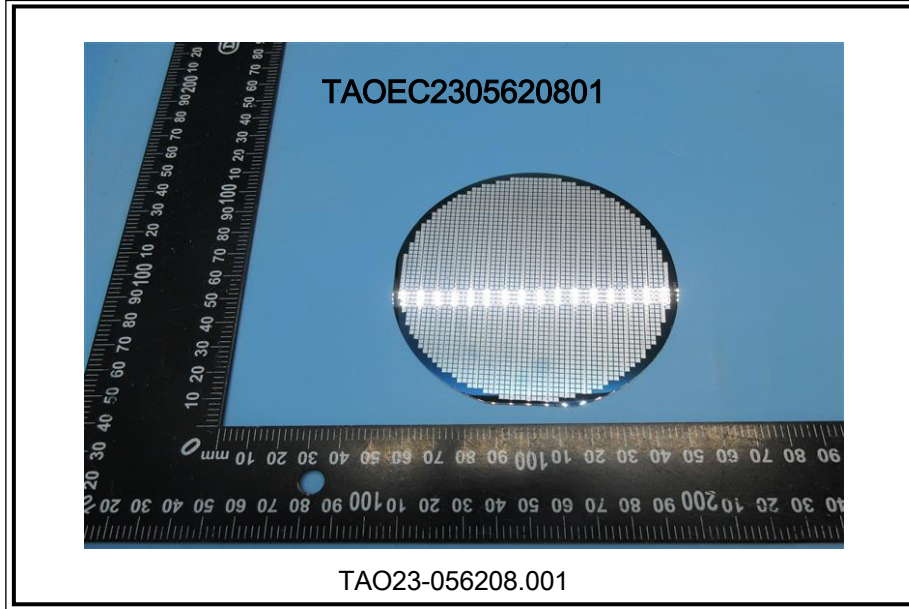
